




### **Awnings**

- Sunair, Tempotest awning material
- To be located above the deck on the second level at the rear of the house

### With the following stipulations:

- 1. That the awning be installed 9.5' -10' above the deck floor, as needed for clearance above existing vents and to achieve the necessary pitch of a 3" drop for every foot of projection from the wall for the extension of the open awning over the existing deck;
- 2. That all awning fabric color be Tempotest 5009/1, with stripes of sand and beige colors;
- 3. That the awning valance be style "E, a simple scallop design"
- 4. That a metal hood (cover) be required
- 5. That the entire metal frame and hood be painted "Sand" color and
- 6. That the awning be the full width of the townhouse, with the allowances made for the existing downspouts

Note: Cluster members are not prohibited from purchasing a motorized retraction system and a wind sensor to be mounted on the roof eaves.








### **Railings**

- Simple wood vertical picket railings with repeated decorative railing treatment.
- Composite materials shown below





### With the following stipulations:

- 1. Any new or replacement deck must conform to composite and/or wood color requirements listed above
- 2. When existing railings, post and baulusters are in need of painting, the raling must be brought into compliance with composite and/or wood color requirements listed above.
- 3. Privacy screens must match the deck railing material and color and conform to the already established size standards
- 4. Alternative manufacturers may be used with an application for staff review.

# **Spiral Staircases**

• Constructed of steel, with a continuous handrail and simple vertical pickets and follow Fairfax County code requirements. All stairs are painted black and are located on rear decks.


### Fence Design

6' high Western Cedar Board-on-board fence, to be located between lots as privacy fences and along rear property lines

With the following stipulations:

- 1. That a 1" x 6" horizontal trim be incorporated at the top (below the capboard) and bottom of the fence
- 2. That the design be modified to include 6" x 6" post and a 2" x 6" capboard
- 3. That the fence be constructed flat and level, with the sections stepped to accommodate any change in grade; that the bottom of the fence follow the grade or be stepped; the "steps" should not exceed 12" at either top or bottom; and all vertical members must be straight and plum;
- 4. That the gate design be solid board with a rounded top

# **Security Lights**

One double-headed security light fixture per house, located at the rear (above the sliding glass door, under the mid-level cantilevered section of the house) with the stipulation that the security lights be directed downwards and have an incandescent light source.





# Windows

All window replacements require an application to be submitted for review by the Design Review Board.











### Solar Panels

- Solar panels must only be installed on a roof that has had new, DRB-approved cluster standard shingles installed within 10 years of the proposed solar panel installation.
- Homeowners must first consider all existing structures prior to selecting location for proposed solar panel system.
- Preferred location for installation of solar panels would be the rear-facing roof, in a manner that is least visible from other lots and street view.
- Visibility of devices and their components must be minimized from public view and may be required to be screened from the street and/or neighboring properties in a manner approved by the TAW Board.
- Flush-mounted solar panels (i.e., the plane of the array is parallel to the roof) on a roof which faces the street, is permitted only if documentation is provided from an independent, solar panel design specialist, who is certified by the North American Board of Certified Energy Practitioners and is licensed in Virginia establishing that installation on the rearfacing roof:
  - I. Increases the cost installation of the solar energy collection device by five percent over the projected cost of the initially proposed installation or
  - II. Reduces the energy production by the solar energy collection device by 10 percent below the projected energy production of the initially proposed installation.
- Installation must be by a qualified, licensed, experienced solar installer.
- Ground mounted panels are not permitted.
- All components of the solar panel system should be integrated into the design of the home.
- The color of the solar panel system components must conform to the color of the roof shingles to the fullest extent practical. Solar "shingles" that mimic the look of a composite shingle are acceptable but should match the color of the current roof shingles as close as is practical.
- Orientation of all solar panels must be the same (horizontal or vertical).
- Roof-mounted solar panel systems must be installed so that the solar panels are flushmounted and centered.
- The solar panel installation should be appropriate for the size and shape of the roof face and set back no less than 18" from each edge of the roof. Solar energy devices (panels) must not break the roof ridgeline
- All pipes, wires, support structures and control devices must be concealed and placed as
  inconspicuously as possible when viewed from all angles.
- Piping and electrical connections must be located directly under and/or within the perimeter of the panels, when possible.
- The homeowner must maintain panels to ensure proper functioning and appearance. This
  includes but is not limited to regular cleaning of the panels. Proof of function must be
  supplied in support of the TAW Board architectural inspection process, conducted every 3

- years or at other times as deemed necessary by the TAW Board. The homeowner must demonstrate to the TAW Board inspection team that the system is operating properly.
- Violations of the rules and regulations contained herein will be pursued the same as any other covenants enforcement in accordance with the Association's published policies and procedures.
